#### 1 Notice of Intention to Suspend the Board of the New England County Council

The Board of the New England County Council was further suspended by the Minister for Local Government for three months from 16th December 2024. By letter dated 10th March 2025 the Minister for Local Government advised

In accordance with section 4380 of the *Local Government Act 1993* I hereby give notice of my intention to amend the order that currently suspends the New England County Council (Council), which took effect on 17 December 2024 by extending the period during which Council is suspended for a further period of 3 months, that is until 17 June 2025.

It is also my intention to extend your appointment as Interim Administrator of Council for this further period during which Council is to be suspended.

I have considered your report of 17 February 2025 about your administration of Council. Based on your observations and advice, I have formed the view that the extension of the period of suspension is necessary to allow you to continue your work to restore the proper and effective functioning of Council before its proposed dissolution.

I thank you for the work that you have done to date and for your ongoing commitment to the important role of Interim Administrator.

### 2 Cash Flow

Due to the dire financial position of the NECC, and the fact that it is almost entirely dependent on the constituent Councils for income regular Cash Flow Projections (CFP)are prepared and shared with the four Councils.

The most recent CFP was prepared on 3rd March 2025. The CFP does not include further contributions from the constituent Councils and projects that the NECC can survive financially until early April.

As the proposal to dissolve the NECC is currently being advertised with submissions closing on 1st April 2025, it is expected that the dissolution of the Council will not be in place until late April or sometime in May.

Assets which are surplus to the needs of NECC and the constituent Councils are being sold with a view to increasing NECC income.

The Weed Action Program (WAP) grant is also unlikely to be received until May.

The constituent councils have so far contributed \$1.6m to keep the NECC operating.

The Office of Local Government has been informed of the possibility that the NECC may be unable to operate by April 2025.

### 3 Sales of Assets

In order to improve the cash position of NECC sales of surplus small plant and vehicles has commenced.

### 4 Proposal to Dissolve New England County Council

Through July 2024 each of the constituent Councils resolved unanimously that the NECC be dissolved.

In October 2024 each Council resolved to submit a proposal under Sec 383 (1) of the Local Government Act to the Minister for Local Government to dissolve the NECC and transfer the responsibilities under the NSW Biosecurity Act to the constituent Councils. The decisions taken by each Council was unanimous.

On 12th December 2024 Armidale Regional Council submitted a formal Proposal to the Minister under Section 383(1) of the Local Government Act to dissolve the New England County Council.
